Here's the "warning" HostSave sent me today regarding our very first billing for monthly "rent" of space on their machine. We received a whole month of free usage as part of signing up with them. But now the free lunch ends. We must start paying them \$6.95 a month forever. The only change in this price that I can predict would be if we started getting greedy about what we want to store on our site, such as three or four times as many photos, or a data base of all the on-the-air contacts all members have made in the last seven years with other ham radio operators. :) Otherwise we take advantage of being small users at a pretty big website discount house.

It looks below like they have not yet charged my card the \$20.85 for the first THREE months yet, but will do it in the next breath. I'd like to use this statement as a bill, if you'll accept it, and you can add it to whatever you planned to send or give to me for any other expenditures on behalf of the LRRRA. As far as I know, the only other charge that is unremunerated at present is the \$70 bill for InterNIC registration. I bet you had the check in hand at Sunday's breakfast, but I still had a bad cold and stayed in bed, so missed it. Hope nobody got my cold. It's a bruiser.
