OPERATOR PRIVILEGES

CONDITIONS OF GRANT

Licensee MUST SIGN on the face hereof before operation of the radio station begins.

When a class of operator privileges has been inserted on this license by the Commission, the person named herein as licensee is authorized to be the control operator of an amateur radio station licensed by this Commission only in the manner and to the extent provided by the class of privileges inserted herein.

When an amateur station call sign has been inserted on this license by the Commission, the person named herein as licensee is authorized to establish an amateur radio station at the fixed operation location herein specified. If operation of the station by remote control is authorized, the location of the control point is also shown. The station shall be identified by the call sign specified herein. When in portable or mobile operation, the station identification shall so indicate.

All authority hereby granted shall be exercised in accordance with the provisions of all treaties, laws, orders, rules and regulations that apply to amateur radio operators and amateur radio stations licensed by the Commission.

This license shall not vest in the licensee any right to operate the station nor any right in the use of authorized frequencies beyond the term hereof, nor in any other manner than authorized herein. This license is subject to the right of use or control by the Government of the United States under section 606 of the Communications Act of 1934, as amended.
